Sydbank is a member and co-owner of Nets, the Danish clearing house. Moreover we are full member of KRONOS, the national RTGS systems, which can handle both DKK and EUR.

Sydbank's international memberships include EBA STEP1 and STEP2, TARGET and Eurogiro. In addition we endorse the Credeuro and ICP conventions.

Primary Product Features

Nostro accounts are free of charge; we pay credit interest – minimum balance requirement of DKK 500,000. Account services are available in DKK, EUR and any other major currency.

We can provide services for Commercial Payments, Low Value or Mass Payments as well as Cash Letter Services. Please see the relevant fact sheets.

Clearing facilities are available in DKK. Sufficient intraday and overnight facilities will be available subject to agreement.

The staff of our payments and investigation departments is specialised in servicing our business partners. All business partners are provided with the contact details of several investigation officers and an account manager who will deliver competent, personal and prompt services.

Value Dates

All transactions will be booked no later than on the value date indicated in the payment order and with the value date indicated.

Interbank payments received before Sydbank's cut-off times are executed and credited to the receiving bank with the same value date as stated in the payment order.

Inquiries

We will clear your inquiry within 24 hours (Only Danish business days and operating hours).

Reference number and contact details of the investigating officer concerning a specific inquiry will appear from the confirmation of your inquiry. You will receive communication via SWIFT MT196/199/999 or email.

Account Information

SWIFT statements will be sent via SWIFT MT950 or MT940 at your choice. MT940s can be sent to a third party, if required.

Our fully automatic SWIFT statements will be sent out at about 6:30am CET and will reach European banks before the opening of business.

Additional services include real time MT900s and MT910s issued upon request.

All account entries include your original reference as received on the underlying SWIFT message for your immediate reference.

Value Adjustments

Value adjustments will be handled on a case by case basis and we will make every effort to achieve the best possible solution for you.

Liquidity Requirements

Intraday and overnight overdraft facilities as well as a full range of FX services are offered as part of this service.
